**MEMORANDUM FOR COMMANDING OFFICERS OF MILITARY DEPARTMENTS
AND DOD COMPONENT INSTALLATIONS IN THE
LAKE, ILLINOIS WAGE AREA**

**SUBJECT: Nonappropriated Fund (NAF) Minimum Wage Schedules #048 -
Lake, Illinois [Wage Area #145]**

The City of Chicago, Illinois, falls within the geographic boundaries of NAF Wage Area 145 Lake, Illinois, and the minimum wage for Chicago will increase to \$15.00 effective July 1, 2021. In accordance with 5 CFR 532.205, the enclosed NAF regular Crafts and Trades wage schedules #048 (145 CHI, 345 MIL, 545 RUS, and 745 DV) are adjusted to reflect the new \$15.00 minimum wage which qualifies as the highest applicable minimum wage in the wage area for schedule computation. These wage schedules are effective July 1, 2021.

Please note that the preceding wage schedules, #047, would normally be effective June 12, 2021, but are currently delayed and have not been issued. These schedules require prior approval of the DoD Wage Committee before issuance, but the DoD Wage Committee is currently inactive while undergoing a Zero Based Review (ZBR) by direction of the Secretary of Defense. Once the ZBR is complete and the DoD Wage Committee resumes and reviews the results, Wage Schedules #047 will be issued and implemented retroactively to the normal effective date.
