ELIGIBILITY: Applicable to all Federal Civilian Employees. The following professional and educational criteria must be met:

LEVEL I Basic

- Must be in the 0201 or 0203 Occupational Series or in a position requiring FECA administration/management duties.

LEVEL II Intermediate

- At least 2 years of experience in a position requiring FECA administration/management duties.
- Complete ICPA Level I Basic Course.
- Pass ICPA Level I Post-test with a score of 80% or higher.

LEVEL III Advance

- At least 3 years as an Agency FECA Program Manager or someone who aspire to manage agency/component level program.
- Complete ICPA Level II Intermediate Course
- Pass ICPA Level II Post-test with a score of 80% or higher.

LEVEL I Credentialing Exam

- Complete ICPA Level I Basic Course.
- Pass ICPA Level I Post-test with a score of 80% or higher.

LEVEL II Credentialing Exam

- Pass the Level I Credentialing Exam with a score of 80% or higher.
- Complete ICPA Level II Intermediate Course.
- Pass ICPA Level II Post-test with a score of 80% or higher.
- Become Credentialed as a DoD Injury Compensation Technical Advisor (DoD ICTA) with a score of 80% or higher on the exam.

LEVEL III Credentialing Exam

- Pass the Level II Credentialing Exam with a score of 80% or higher.
- Pass ICPA Level III Post-test with a score of 80% or higher.
- Become Credentialed as a DoD Injury Compensation Program Manager (DoD ICPM) with a score of 80% or higher on the exam.

WHEN: Level I, II, and III training classes are open and available for the upcoming calendar year.
